BadgerNet

BadgerNet is the electronic patient record used by Maternity, to record and manage their patient data, within the North East and North Cumbria region. The Great North Care Record (GNCR) and the Local Maternity and Neonatal Systems (LMNS) have teamed up to work together to develop and start sharing maternity data, directly from their EPR, into GNCR.

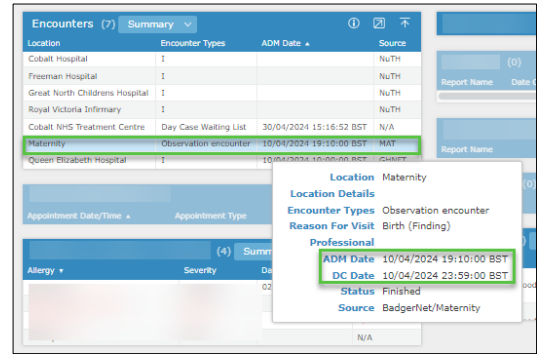

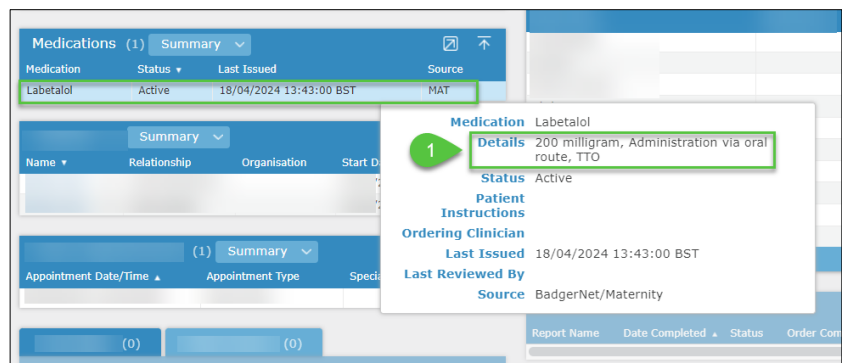

The pregnancy is closed on GNCR 6-14 weeks after a baby loss or a birth. If information is still required, it can be found in the Miscellaneous Reports and Care Plans.

1. This section will say 'Active Pregnancy Detected' or 'Closed Pregnancy Detected'. The closed pregnancy will appear when the pregnancy has been closed on BadgerNet but the Pregnancy Summary is still appearing within GNCR (6 weeks post closure).
2. Birth Outcome will either identify a 'Live Birth' or 'Fetal Loss' – if there has been a loss the date of death will appear.
3. Birth Type will appear once a birth has occurred, it will tell you how the pregnant person gave birth, for example via a caesarean section or vaginal birth.
4. Any previous pregnancies will appear here. When you click on 'Previous pregnancies' the report will provide information on Date of Birth, Length of gestation at birth, Delivery finding and Birth Outcome.




